

Reporting Animal-Related Concerns at the University of Maryland, College Park

Concerns or questions related to the animal care program should be directed to one or more of the following:

Examples of situations that must be reported to the IACUC include the following:

- conditions that jeopardize the health or well-being of animals
- chronic failure to provide food, water, or space for animals
- conduct of animal-related activities without appropriate IACUC review and approval or beyond the date of IACUC protocol expiration
- participation in animal-related activities by individuals who are not appropriately qualified or trained
- failure to monitor animals post-procedurally to ensure well-being
